Emergency Tuition Fee Exemption in Spring Semester 2020

1. Overview

Kyushu University accepts applications of Emergency Tuition Fee Exemption from students with a large decline in household income due to the direct or indirect impact of the coronavirus outbreak. The exemption amount of the tuition fee is three levels — full, half or quarter amount of the tuition fee for the spring semester. (For applicants who have already paid the tuition fee and are approved for Emergency Tuition Fee Exemption, we will refund according to the exemption amount.)

In the normal exemption screening, the income of the previous year is examined. This time, however, in the screening of Emergency Tuition Fee Exemption, the estimated income after the income decrease is examined.

2. Eligible applicant

Students who meet both of the following conditions (1 and 2) can apply for Emergency Tuition Fee Exemption.

- Undergraduate and graduate students whose householder's*1 income*2 has declined significantly with business suspension or closure due to the impact of the coronavirus outbreak as compared to the income before the occurrence of cause for income decreasing.
- Students who meet the requirements for the tuition fee exemption of Kyushu University. (Students who have already applied for the tuition fee exemption for this semester are also eligible.)

householder's*1 ... In principle, "householder" is you (applicant) or your spouse. However, if your family (excluding a spouse) lives in Japan, "householder" is family members who provide the family budget.

income*2... If you are supported financially by parents or others, "income" means the total amount of the parents' (or other's) remittance and your income such as part-time job wage.

If you are a self-supporting student, "income" means the total income of you and your spouse.

from Thursday May 21th to Wednesday June 3rd, 2020

- If there are insufficiencies on your application form, university staff will contact you via email or phone. Please respond immediately to it. If you do not respond for many days, we cannot accept your application.

(For students who have already applied for the tuition fee exemption of Kyushu

University for the spring and fall semester together)

If Emergency Tuition Fee Exemption is implemented for the fall semester and you wish to apply

for it, you need to apply for it during the application period for the fall semester.

5. Result of application

Result notification: Late in July 2020

Result will be notified to "Message For You" on Student Portal System.

6. Tuition Fee (after the application)

[Students who have already paid the tuition fee of the spring semester 2020]

If your application is approved, we will refund the exempted tuition fee in late July — after the

result notification. It will be returned to your bank account registered as an account for the tuition

fee payment at the enrollment procedure.

(Students who have not paid the tuition fee of the spring semester 2020)

The tuition fee payment (the direct debit from your bank account) is deferred until the application

result is notified (late July). If your application is approved as a half-exemption or

quarter-exemption, or your application is disapproved, please pay the tuition fee following to the

instruction on the result notification.
