Chapter I General Provisions

(Purpose)

Article 1 (1) Kyushu University (hereinafter referred to as the "University") aims to, as the core of scholarly activities, impart wide-ranging knowledge, teach and research specialized arts and sciences in depth, and have students develop their intellectual, ethical and practical abilities, in accordance with the spirit of the Basic Act on Education (Act No. 120 of 2006).

(2) The University shall conduct education and research intended to accomplish the purpose referred to in the preceding paragraph and disseminate the results thereof widely, thereby contributing to the development of society.

(Self-assessment)

Article 2 (1) The University shall inspect and assess the status of educational and research activities and other activities carried out at the University and publicize the results thereof in order to enhance the level of its education and research, and to accomplish its purpose and social mission.

(2) The University shall have the results of the self-inspection and assessment referred to in the preceding paragraph and those of various evaluations such as third-party evaluations reflected in its objectives and plans, and make constant efforts for continuous reforms.

(Publication of Status of Educational and Research Activities)

Article 2-2 The University shall publicize the status of its educational and research activities in order to contribute to the dissemination of education and research results and the promotion of use of such results.

Chapter II Organizations

Article 3 (1) The University has in place undergraduate schools and departments as set forth in the following table:

(2) The purposes relevant to development of human resources and other educational and research purposes for each undergraduate school or department are provided separately by regulations.

(3) The policies relevant to graduation certification, the policies relevant to the formation and implementation of curriculum, and the policies relevant to acceptance of enrolled students are provided separately for each undergraduate school or department.

(4) The University shall compose an organization consisting of the necessary faculty members and administrative staff, etc. in accordance with the size of the undergraduate

school and the types and fields of degrees it confers in order to achieve the purpose of education and research of the undergraduate school.

(5) The University, in the composition of the organization as stipulated in the preceding paragraph, shall secure collaboration and organized coordination system under the appropriate division of roles among its faculty members and administrative staff, etc. and shall clarify where the responsibility for education and research lies, in order to conduct administration of educational and research activities, etc. of the undergraduate school systematically and effectively.

(6) The composition of a faculty organization and other necessary matters of each undergraduate school, among those established based on the preceding two paragraphs, are provided separately by regulations.

(7) The duration of study, curriculum, admission, withdrawal, graduation, and other matters necessary for schooling of students of undergraduate schools are provided by the General Regulations of Undergraduate Schools of Kyushu University (Kyushu University Regulation No. 2 of 2004).

#### (Graduate Schools/Faculties)

Article 4 (1) The University has in place Kyushu University Graduate Schools/Faculties (hereinafter referred to as the "Graduate Schools/Faculties").

(2) In accordance with the purpose of the University, the Graduate Schools/Faculties aim to teach and research academic theory and application, delving into the depth thereof, or to cultivate students' deep knowledge and excellent abilities as needed to engage in occupations that require advanced expertise, thereby contributing to the advancement of culture.

(3) Among the Graduate Schools/Faculties, those aiming to teach and research academic theory and application and to cultivate students' deep knowledge and excellent abilities as needed to engage in occupations that require advanced expertise are set up as professional graduate schools.

Article 5 The Graduate Schools/Faculties consist of graduate schools organized according to the educational purposes (including joint graduate schools established as basic organizations for implementation of joint courses of graduate schools, etc. provided in Article 30-2, paragraph (1) of the Standards for Establishment of Graduate Schools (Order of the Ministry of Education, Science and Culture No. 28 of 1956 (referred to below as the "Standards for Establishment of Graduate Schools")), and graduate faculties organized according to the research purposes and in consideration of educational necessity, both of which are established as basic organizations for education and research other than the graduate school departments referred to in the proviso to Article 100 of the School Education Act (Act No. 26 of 1947).

Article 6 (1) The graduate schools established to constitute the Graduate Schools/Faculties referred to in the preceding Article are as set forth in the left-hand column of the following table, and the University has in place departments set forth in the right-hand column of the same table these graduate schools:

(2) The purposes relevant to development of human resources and other educational and research purposes for each graduate school or department are provided separately by regulations.

(3) The policies relevant to graduation certification, the policies relevant to the formation and implementation of curriculum, and the policies relevant to acceptance of enrolled students are provided separately for each graduate school or department.

(4) Doctoral programs aim to cultivate students' advanced research abilities in their major fields as needed to carry out research activities independently as researchers or engage in other highly specialized work and a wealth of knowledge that supports such abilities.

(5) Master's programs aim to impart deep and detailed knowledge from a broad perspective, and cultivate students' research abilities in their major fields or excellent abilities as needed to engage in occupations that require advanced expertise in addition to such research abilities.

(6) Professional degree programs aim to cultivate students' deep knowledge and excellent abilities as needed to engage in occupations that require advanced expertise; among these, the professional degree program at a law school aims exclusively to provide education to train legal professionals.

(7) The University shall compose an organization consisting of the necessary faculty members and administrative staff, etc. in accordance with the size of the graduate school and its departments, and the types and fields of degrees it confers in order to achieve the purpose of education and research of the graduate school.

(8) The University shall secure an appropriate division of roles and organized coordination system among its faculty members and administrative staff, etc. and shall pay special attention to ensure that organized education is provided, in order to ensure the systematic and effective administration of the educational and research activities, etc. of the graduate school.

(9) The composition of a faculty organization and other necessary matters of each graduate school, among those established based on the preceding two paragraphs, are provided separately by regulations.

(10) The duration of study, educational methods, admission, withdrawal, completion of programs, and other matters necessary for schooling of students of graduate schools are provided by the General Regulations of Graduate Schools of Kyushu University (Kyushu University Regulation No. 3 of 2004).

Article 7 The graduate faculties established to constitute the Graduate Schools/Faculties referred to in Article 5 are as set forth in the following:

- (i) Faculty of Humanities;
- (ii) Faculty of Social and Cultural Studies;
- (iii) Faculty of Human-Environment Studies;
- (iv) Faculty of Law;
- (v) Faculty of Economics;
- (vi) Faculty of Languages and Cultures;
- (vii) Faculty of Science;
- (viii) Faculty of Mathematics;
- (ix) Faculty of Medical Sciences;
- (x) Faculty of Dental Science;
- (xi) Faculty of Pharmaceutical Sciences;
- (xii) Faculty of Engineering;
- (xiii) Faculty of Design;
- (xiv) Faculty of Information Science and Electrical Engineering;
- (xv) Faculty of Engineering Sciences; and
- (xvi) Faculty of Agriculture.

(Faculty of Arts and Science)

Article 7-2 (1) The University has in place the Faculty of Arts and Science as a university-wide organization for fostering the basis for learning that all students of the University are expected to have in common.

(2) The internal organization and other necessary matters of the Faculty of Arts and Science are provided separately.

(Institute for Advanced Study)

Article 7-3 (1) The University has in place the Institute for Advanced Study as a university-wide organization for fostering human resources through the promotion and development of advanced research activities and widely sharing the research results with society.

(2) The internal organization and other necessary matters of the Institute for Advanced Study are provided separately.

(Attached Research Institutes)

Article 8 (1) The University has in place research institutes attached to the University.

(2) The research institutes referred to in the preceding paragraph (hereinafter referred to as the “Attached Research Institutes”) are as set forth in the left-hand column of the following table, and the purposes of these Attached Research Institutes are as set forth in the right-hand column of the same table:

(3) The internal organization and other necessary matters of each Attached Research Institute are provided separately by regulations.

(International Institute)

Article 8-2 (1) The University has in place the International Institute for Carbon-Neutral Energy Research.

(2) The International Institute for Carbon-Neutral Energy Research aims to create basic science in carbon-neutral energy research and contribute to solving challenges toward achieving a sustainable and environmentally-friendly society.

(3) The internal organization and other necessary matters of the International Institute for Carbon-Neutral Energy Research are provided separately by regulations.

(Hospital)

Article 9 (1) The University has in place an affiliated hospital in the School of Medicine and the School of Dentistry, as an educational and research facility for their joint use, which is called Kyushu University Hospital (hereinafter referred to as the "Hospital").

(2) The internal organization and other necessary matters of the Hospital are provided separately by regulations.

(University Library)

Article 10 (1) The University has in place the University Library.

(2) The internal organization and other necessary matters of the University Library are provided separately by regulations.

#### Article 11 Deleted

(Research Institute for Information Technology)

Article 12 (1) The University has in place the Research Institute for Information Technology as a nationwide joint use facility for conducting practical investigation and research, developing and providing infrastructure equipment or the like, and carrying out other specialized operations for the purpose of promoting the use of information in research, education and other activities.

(2) In addition to the operations referred to in the preceding paragraph, the Research Institute for Information Technology carries out system development for the information infrastructure in the University.

(3) The internal organization and other necessary matters of the Research Institute for Information Technology are provided separately by regulations.

(Joint Use Educational Center)

Article 12-2 The Faculty of Arts and Science provided in Article 7-2 is shall made available for the use by other universities as a Joint Use Educational Center certified by the Minister of Education, Culture, Sports, Science and Technology pursuant to the provisions of Article 143-2, paragraph (2) of the Enforcement Regulation of the School Education Act (Order of the Ministry of Education No. 11 of 1947; hereinafter referred to as the "School Education Act Enforcement Regulation").

(Joint Usage/Research Centers)

Article 12-3 The Attached Research Institutes, etc. set forth in the following table shall serve for the development of academic research as respective Joint Usage/Research Centers certified by the Minister of Education, Culture, Sports, Science and Technology pursuant to the provisions of Article 143-3, paragraph (2) of the School Education Act Enforcement Regulation:

(Platform of Inter / Transdisciplinary Energy Research)

Article 12-4 (1) The University has in place the Platform of Inter / Transdisciplinary Energy Research, as a university-wide organization to promote advanced research and educational activities in the energy field.

(2) The internal organization and other necessary matters of the Platform of Inter / Transdisciplinary Energy Research are provided separately.

(Institute for Asian and Oceanian Studies)

Article 12-5 (1) The University has in place the Institute for Asian and Oceanian Studies as a university-wide organization for promoting research and educational activities aimed at solving social issues in the Asia and Oceania region and discovering and presenting these issues.

(2) The internal organization and other necessary matters of the Institute for Asian and Oceanian Studies are provided separately.

(Quantum and Spacetime Research Institute)

Article 12-6 (1) The University has in place the Quantum and Spacetime Research Institute as a university-wide organization for accelerating collaboration and cooperation between the disciplines of space science and quantum science.

(2) The internal organization and other necessary matters of the I Quantum and Spacetime Research Institute are provided separately.

(Centers for Common Education and Research)

Article 13 (1) The University has in place Centers for Common Education and Research as organizations having any of functions in the following items which the faculty members of the University and other persons engage in education and research activities jointly:

- (i) to mainly support educational or research activities;
- (ii) to mainly promote education or research; or
- (iii) to mainly promote other university-wide operations.

(2) Centers for Common Education and Research are as set forth in the left-hand column of the following table, and among these Centers for Common Education and Research, those subject to the period of existence will cease to exist upon the date of expiration of the respective period of existence as set forth in the right-hand column of the same table:

(Information Infrastructure Initiative)

Article 15 (1) The University has in place the Information Infrastructure Initiative as an organization for providing university-wide information support.

(2) The purposes of the Information Infrastructure Initiative are as set forth in the following:

(i) develop university-wide information infrastructure; and

(ii) provide comprehensive support for operations relevant to education and research and university administration carried out using information technology.

(3) The composition and other necessary matters of the Information Infrastructure Initiative are provided separately by regulations.

(Relocation Coordination Executive)

Article 15-2 (1) The University has in place the Relocation Coordination Executive as an organization for promoting the project of the integrated transfer and the development plan for the Ito Campus.

(2) The composition and other necessary matters of the Relocation Coordination Executive are provided separately by regulations.

(Endowment Management Executive)

Article 15-3 (1) The University has in place the Endowment Management Executive as an organization for promoting the support grant program by the Kyushu University Fund and the fund enhancement program (hereinafter referred to as the "fund programs").

(2) The composition and other necessary matters of the Endowment Management Executive are provided separately by regulations.

(Public Relations Initiative)

Article 15-4 (1) The University has in place the Public Relations Initiative as an organization for drawing up public relations strategies and promoting public relations activities.

(2) The composition and other necessary matters of the Public Relations Initiative are provided separately by regulations.

(Project Headquarters)

Article 15-5 (1) The University has in place the Project Headquarters as an organization for promoting globalization on a university-wide basis.

(2) The composition and other necessary matters of the Project Headquarters are provided separately by regulations.

(Academic Research and Industrial Collaboration Management Office of Kyushu University)

Article 15-6 (1) The University has in place the Academic Research and Industrial Collaboration Management Office of Kyushu University as an organization to promote the university wide academic research and industry-academia-government collaboration.

(2) The composition and other necessary matters of the Academic Research and Industrial

Collaboration Management Office of Kyushu University are provided separately by regulations.

(Integrated Initiative for Designing Future Society)

Article 15-7 (1) The University has in place the Integrated Initiative for Designing Future Society as an organization to promote university-wide initiatives for solving social issues.

(2) The composition and other necessary matters of the Integrated Initiative for Designing Future Society are provided for separately by regulations.

(Data-Driven Innovation Initiative)

Article 15-8 (1) The University has in place the Data-Driven Innovation Initiative as an organization to promote university-wide data-driven activities and to study the ideal form of a new digital society.

(2) The composition and other necessary matters of the Data-Driven Innovation Initiative are provided for separately by regulations.

(Promoting Organization for Future Creators)

Article 15-9 (1) The University has in place the Promoting Organization for Future Creators as an organization for promoting educational reform and the improvement of educational quality in doctoral programs and other programs in the University.

(2) The composition and other necessary matters of the Promoting Organization for Future Creators are provided for separately by regulations.

(Offices)

Article 16 (1) The University has in place offices as organizations for planning, promoting or supporting specific important matters.

(2) The offices referred to in the preceding paragraph are as set forth in the left-hand column of the following table, and the purposes of these offices are as provided respectively in the right-hand column of the same table:

(3) The internal organization and other necessary matters of each office referred to in the preceding paragraph are provided separately.

(Ito Clinic)

Article 16-2 (1) The University has in place Ito Clinic (hereinafter referred to as the "Clinic").

(2) The internal organization and other necessary matters of the Clinic are provided separately.

(Administrative Organizations)

Article 17 (1) The University has in place the Administration Bureau to conduct administrative work relevant to general affairs, accounting, facilities, welfare and guidance for students and other matters.

(2) The University has in place administrative offices in undergraduate schools, graduate schools, etc. of the University to conduct their respective administrative work; provided, however, that, if necessary, the University has in place an administrative office in two or more undergraduate schools, etc. to conduct their administrative work collectively.

(3) In addition to the administrative organizations provided in the preceding two paragraphs, the University has in place the Audit and Compliance Office to conduct internal audits and assist audit work by Auditors.

(4) The internal organization and other necessary matters of the administrative organizations referred to in the preceding three paragraphs are provided separately by regulations.

(Tokatsugijutubu and Technical Divisions)

Article 17-2 (1) The University has in place the Tokatsugijutubu as a university-wide organization concerning technology support for education and research.

(2) The University may have in place technical divisions in undergraduate schools, graduate schools, the graduate faculties, the Faculty of Arts and Science, Attached Research Institutes or the like to provide technical support for education and research.

(3) The internal organization and other necessary matters of the Tokatsugijutubu referred to in the paragraph (1) and the technical divisions referred to in the preceding paragraph are provided separately.

Chapter III Officers, Employees, etc.

(Officers)

Article 18 Pursuant to the provisions of Article 10 of the National University Corporation Act (Act No. 112 of 2003); hereinafter referred to as the "Corporation Act"), the University has in place a President (referred to as the "President"), not more than 10 Executive Vice Presidents (or not more than 11 Executive Vice Presidents if one or more of them are part-time Executive Vice Presidents (limited to a person who is not an officer or employee of the University at the time of appointment (hereinafter referred to as a "person outside the University"))), and two Auditors, as its officers.

(2) Two or more of the Executive Vice Presidents referred to in the preceding paragraph (or one or more of these Executive Vice Presidents if a person outside the University has been appointed as the President) are appointed from among persons outside the University.

(3) At least one of the Auditors referred to in paragraph (1) serves on a full-time basis.

Article 19 (1) The President takes charge of university affairs, supervises university employees, represents the University, and presides over its operations.

(2) The President may request reports from Executive Vice Presidents or employees relevant to the operations entrusted thereto under this Regulation or other regulations, etc. designated by the President or may order them to take necessary measures or may take necessary measures him/herself.

Article 20 Executive Vice Presidents, as provided by the President, administer the operations of the University by assisting the President, perform the duties of the President in the place if the

President is unable to attend to the duties, and perform the duties of the President when the post is vacant.

Article 21 (1) Auditors audit the operations of the University. In this case, Auditors must make an audit report.

(2) Auditors may, at any time, request reports from officers (excluding Auditors), Management Policy Council members and employees regarding administrative work, as well as projects and programs, or investigate the status of the operations and property of the University.

(Employees)

Article 22 (1) The University has in place faculty, administrative staff, technical staff, highly specialized staff, and other necessary staff.

(2) The faculty referred to in the preceding paragraph consists of professors, associate professors, lecturers, assistant professors, research associates (*jun jokyō*), and research associate (*joshu*; (referred to as “*kyōmu joshu*”)).

(3) The duties of professors, associate professors, lecturers, assistant professors, and research associates (*kyōmu joshu*) shall be governed by the provisions of in Article 92 of the School Education Act, and the duty of research associates (*jun jokyō*) shall be to assist professors and associate professors in their duties.

(Senior Vice Presidents)

Article 23 (1) Several Senior Vice Presidents are appointed, as provided by the President, to help the President and take charge of university affairs under the order from the President.

(2) Persons designated by the President from among Executive Vice Presidents concurrently serve as Senior Vice Presidents.

(3) Notwithstanding the provisions of the preceding paragraph, if the President finds it particularly necessary, persons designated by the President from among employees may concurrently serve as Senior Vice Presidents.

(Vice Presidents)

Article 24 (1) Several Vice Presidents are appointed, as provided by the President, to help Executive Vice Presidents in performing their duties.

(2) Vice Presidents are designated by the President from among professors and other employees.

(Assistants to President)

Article 24-2 (1) The University may have in place several assistants to the President, as provided by the President, to take charge of specific matters ordered by the President and aid the President.

(2) Assistants to the President are designated by the President from among professors and other employees.

(Faculty Directors)

Article 25 (1) The University has in place directors in undergraduate schools, graduate schools, graduate faculties, the Faculty of Arts and Science, Attached Research Institutes, the International Institute for Carbon-Neutral Energy Research, the Hospital, the University Library, and the Research Institute for Information Technology (hereinafter referred to as the "faculties") (the director of the faculties are hereinafter collectively referred to as the "Faculty Directors").

(2) Faculty Directors administer the operations of their relevant faculties.

- (3) The University may have in place an Assistant Faculty Director in each faculty.
- (4) An Assistant Faculty Director of each faculty, as provided by the Faculty Director, handles the operations of the faculty by assisting the Faculty Director, performs the duties of the Faculty Director in his/her place if the Faculty Director is unable to attend to his/her duties, and performs the duties of the Faculty Director if the post is vacant.
- (5) The appointment procedures and other necessary matters relevant to Faculty Directors and Assistant Faculty Directors are provided separately by regulations.
- (6) The University may have in place Department Directors in departments in undergraduate schools and departments in graduate schools.
- (7) The appointment procedures and other necessary matters relevant to Department Directors shall be provided separately.

(Directors of Centers)

- Article 26 (1) The University has in place Directors in Centers for Common Education and Research (the directors are hereinafter referred to as the "Directors").
- (2) The Directors administer the operations of relevant Centers for Common Education and Research.
  - (3) The University may have in place an Assistant Director in each Center for Common Education and Research.
  - (4) An Assistant Director, as provided by the Director, handles the operations of the Center for Common Education and Research by assisting the Director, performs the duties of the Director in his/her place if the Director is unable to attend to his/her duties, and performs the duties of the Director if the post is vacant.
  - (5) The appointment procedures and other necessary matters relevant to Directors and Assistant Directors are provided separately by regulations.

(Director of the Clinic)

- Article 26-3 (1) The University has in place a Director in the Clinic.
- (2) The Director has jurisdiction over the operations at the Clinic.
  - (3) The Director is designated by the President from among professors.

Chapter IV Management Policy Council, Board of Trustees, Management Council, Education and Research Council, and Presidential Selection and Inspection Committee

(Management Policy Council)

- Article 26-4 (1) The University has in place a Management Policy Council under the provisions of Article 21-9, paragraphs (1) and (3) of the Corporation Act as an organization to adopt resolutions on management policy matters provided in the items of Article 21-5, paragraph (1) of the Corporation Act and supervise whether the management of the University is being carried out appropriately based on the adopted resolutions.
- (2) The proceedings and other necessary matters relevant to the Management Policy Council are provided separately by regulations.

(Board of Trustees)

- Article 27 (1) The University has in place a Board of Trustees consisting of the President and Executive Vice Presidents to deliberate on the matters provided in items of Article 11, paragraph (3) of the Corporation Act.

(2) The proceedings and other necessary matters relevant to the Board of Trustees are provided separately by regulations.

(Management Council)

Article 28 (1) The University has in place a Management Council under the provisions of Article 20 of the Corporation Act as an organization to deliberate on important matters relevant to the management of the University.

(2) The proceedings and other necessary matters relevant to the Management Council are provided separately by regulations.

(Education and Research Council)

Article 29 (1) The University has in place an Education and Research Council under the provisions of Article 21 of the Corporation Act as an organization to deliberate on important matters relevant to education and research at the University.

(2) The proceedings and other necessary matters relevant to the Education and Research Council are provided separately by regulations.

(Presidential Selection and Inspection Committee)

Article 30 (1) The University has in place a Presidential Selection and Inspection Committee (hereinafter referred to as the "Selection Committee") pursuant to the provisions of Article 12, paragraphs (2) to (5) of the Corporation Act.

(2) Necessary matters relevant to the organization of the Selection Committee are provided separately by regulations.

Chapter V Faculty Council

Article 31 (1) The University has in place a faculty council in each of the faculties (excluding the Hospital and the University Library).

(2) The organization, matters for deliberation, proceedings and other necessary matters relevant to a faculty council are provided by the General Regulations for Faculty Councils of Kyushu University (Kyushu University Regulation No. 8 of 2004).

Chapter VI Miscellaneous Provisions

(Miscellaneous Provisions)

Article 32 Beyond what is provided in these Regulations, matters necessary for accomplishing the purpose of the University are provided separately by regulations.

Supplementary Provisions

(1) These Regulations come into effect as of April 1, 2004.

(2) The Kyushu University School of Health Sciences (hereinafter referred to as the "School of Health Sciences"), established in the University pursuant to the provisions of Article 16, paragraph (1) of the Supplementary Provisions of the Corporation Act, is abolished as of the date on which the students enrolled in the School of Health Sciences as of April 1, 2004, will cease to be enrolled therein.

(3) The completion of the curriculum by the students enrolled in the School of Health Sciences referred to in the preceding paragraph and other matters necessary for the education of the

referenced students shall be governed by the provisions of the Regulations of the School of Health Sciences of Kyushu University (effective date: April 8, 1971), etc.

(4) For the graduation of or completion of graduate programs by the students enrolled in the Kyushu Institute of Design, which is to continue to exist pursuant to the provisions of Article 17 of the Supplementary Provisions of the Corporation Act until the date on which the students enrolled in the institute as of September 30, 2003, will cease to be enrolled therein (the referenced students are hereinafter referred to as the "enrolled students"), necessary education shall be provided by the School of Design of Kyushu University (hereinafter referred to as the "School of Design") or the Graduate School of Design of Kyushu University (hereinafter referred to as the "Graduate School of Design").

(5) The completion of the curriculum by the enrolled students referred to in the preceding paragraph and other matters necessary for the education of the referenced students shall be governed by the provisions of the Regulations of the Kyushu Institute of Design (effective date: April 1, 1993) and other regulations; provided, however, that any matters that may not be governed by those regulations are as provided by the President or the Faculty Council of the School of Design or of the Graduate School of Design.

(6) The Attached Research Institutes, etc. provided in Article 12-3 shall continue to exist until March 31, 2022, the date on which the certification by the Minister of Education, Culture, Sports, Science and Technology expires.

(7) The Space Environment Research Center provided in Article 13, paragraph (1) shall continue to exist until March 31, 2012.

(8) The affiliated institutes provided in Article 14, paragraph (1) shall continue to exist, namely, the Institute of Environmental Systems attached to the Faculty of Engineering, until March 31, 2008, the Research Center for Prevention of Infectious Diseases attached to the Medical Institute of Bioregulation, until March 31, 2011, and the Dynamics Simulation Research Center and the Research Center for Fusion Plasma Engineering Science, both attached to the Research Institute for Applied Mechanics, until March 31, 2007.

(9) In addition to the regulations or the like provided pursuant to the Corporation Act and other related laws and regulations, these Regulations or the like, the provisions of the regulations or the like of Kyushu University established pursuant to the Act for Establishment of National Schools (Act No. 150 of 1949) prior to repeal shall be applied directly or applied mutatis mutandis until otherwise provided for by regulations, as provided by the President, with regard to any successive, typical or simple matters for which the President finds such application necessary.

#### Supplementary Provisions (Kyushu University Regulation No. 193 of 2004)

(1) These Regulations come into effect as of April 1, 2005.

(2) Notwithstanding the provisions of Article 6, paragraph (1) after amendment, the Department of Development and Social Systems of the Graduate School of Human-Environment Studies shall continue to exist until the date on which the students enrolled in the department as of March 31, 2005, will cease to be enrolled therein.

#### Supplementary Provisions (Kyushu University Regulation No. 4 of 2005)

(1) These Regulations come into effect as of July 15, 2005, and apply from July 1, 2005.

(2) The Digital Medicine Initiative and the Asian Research Center, both provided in Article 13, paragraph (1) after amendment, shall continue to exist until June 30, 2010.

#### Supplementary Provisions (Kyushu University Regulation No. 23 of 2005)

These Regulations come into effect as of November 7, 2005.

Supplementary Provisions (Kyushu University Regulation No. 30 of 2005)

(1) These Regulations come into effect as of April 1, 2006.

(2) Notwithstanding the provisions of Article 3, paragraph (1) after amendment, the Department of General Pharmaceutical Sciences is to continue to exist until the date on which the students enrolled in said department as of March 31, 2006, will cease to be enrolled therein.

Supplementary Provisions (Kyushu University Regulation No. 2 of 2006)

These Regulations come into effect as of June 1, 2006.

Supplementary Provisions (Kyushu University Regulation No. 25 of 2006)

These Regulations come into effect as of October 1, 2006.

Supplementary Provisions (Kyushu University Regulation No. 37 of 2006)

(1) These Regulations come into effect as of April 1, 2007.

(2) The Center for East Asian Ocean-Atmosphere Research and the Advanced Fusion Research Center, both attached to the Research Institute for Applied Mechanics and provided in Article 14, paragraph (1) after amendment, shall continue to exist until March 31, 2017.

(3) The position of research associates (*jun jokyo*) provided in Article 22, paragraph (2) after amendment is abolished as of the date on which the persons holding the position as of April 1, 2007, will cease to hold it.

Supplementary Provisions (Kyushu University Regulation No. 27 of 2007)

These Regulations come into effect as of November 1, 2007.

Supplementary Provisions (Kyushu University Regulation No. 31 of 2007)

These Regulations come into effect as of December 26, 2007.

(1) These Regulations come into effect as of April 1, 2008.

Supplementary Provisions (Kyushu University Regulation No. 1 of 2010)
