

Kyushu University Animal Experimentation Detailed Regulations

Kyushu University Detailed Regulation No. 19 of 2014
Established: March 23, 2015
Last amended: November 17, 2021
(Kyushu University Detailed Regulation No. 22 of 2021)

(Purpose)

Article 1 These detailed rules are established pursuant to the provisions of Article 37, paragraph (1) of the Kyushu University Animal Experimentation Regulations (Kyushu University Regulation No. 129 of 2014; hereinafter referred to as the “Regulations”) to specify necessary matters concerning the implementation of the Regulations.

(Procedures for Review of Animal Experiments)

Article 2 Applications specified in Article 10, paragraph (1) and (2) of the Regulations shall be submitted in the prescribed format.

(Reporting of Experimental Results)

Article 3 The reports specified in Article 10, paragraph (7) and (8) of the Regulations shall be submitted in the prescribed format.

(Procedures for the Establishment of Animal Housing Facilities or Laboratories)

Article 4 (1) The applications specified in Article 13, paragraph (1) of the Regulations and Article 15, paragraph (1) of the Regulations shall be submitted in the prescribed format.
(2) The notification specified in Article 18, paragraph (1) of the Regulations shall be made using the prescribed form.

(Record Keeping and Reporting)

Article 5. The reports specified in Article 25, paragraph (2) and (3) of the Regulations shall be made using the prescribed form.

(Measures in Case of Accidents, etc.)

Article 6 Reports specified in Article 29, paragraph (2) and (3) of the Regulations shall be submitted in the prescribed format.

(Emergency Response)

Article 7 Reports specified in Article 30, paragraph (4) of the Regulations shall be submitted in the prescribed format.

(Registration of Experiment Staff)

Article 8 (1) Applications for registration as experimental staff as specified in Article 32, paragraph (1) of the Regulations shall be submitted in the prescribed format.

(2) The President shall issue the prescribed Animal Experiment Staff Registration Certificate to persons registered as experimental personnel in accordance with the provisions of Article 32, paragraph (2) of the Regulations.

(Health Examination)

Article 9 The health examination prescribed in Article 33, paragraph (2) of the Regulations may be replaced by the general periodic health examination prescribed in Article 12, paragraph (1), item (ii) of the Kyushu University National University Corporation Safety and Health Management Regulations for Employees (Kyushu University Regulation No. 23 of 2004) for employees, and by the periodic health examination for students.

(Report on Self-Inspection and Evaluation)

Article 10 The self-inspection and evaluation specified in Article 34, paragraph (1) of the Regulations shall be conducted using the prescribed form.

2 The report on the results of the self-inspection and evaluation specified in Article 34, paragraph (2) and (3) of the Regulations shall be submitted using the prescribed form.

(Miscellaneous Provisions)

Article 11 These Detailed Rules shall be amended after approval by the Animal Experiment Committee.

Supplementary Provisions

These Detailed Regulations come into effect as of April 1, 2015.

Supplementary Provisions (Kyushu University Detailed Regulation No.7 of 2016)

These Detailed Regulations come into effect as of October 24, 2016

Supplementary Provisions (Kyushu University Detailed Regulation No.9 of 2016)

These Detailed Regulations come into effect as of March 23, 2017.
