

Kyushu University Detailed Regulations for Safety Management of Experiments involving genetic modification

Kyushu University Detailed Regulation No. 12 of 2004  
Established: April 1, 2004  
Last amended: April 1, 2016  
(Kyushu University Detailed Regulation No. 22 of 2015)

(Purpose)

Article 1 These Detailed Regulations are established pursuant to Article 27 of the Kyushu University Regulations for Safety Management of Experiments involving genetic modification (Kyushu University Regulation No. 82 of 2004; hereinafter referred to as the “Regulations”) to prescribe necessary matters concerning the procedures for applying for experimental plans for genetic recombination experiments (hereinafter referred to as “experiments”).

(Application for experimental plans, etc.)

Article 2 Applications for experimental plans as specified in Article 10, Paragraph 1 of the Regulations shall be made using the prescribed form.

(2) The provisions of the preceding paragraph shall apply mutatis mutandis to cases where an experimental plan is to be changed.

(Markings related to experiments)

Article 3 The markings specified in Article 15 of the Regulations shall be made in the prescribed format.

(Signs for facilities used for experiments)

Article 4 Facilities used for experiments shall display signs in the prescribed format. However, this shall not apply to facilities used for P1 level experiments.

(Recording and preservation of experiments)

Article 5 The person responsible for the experiment shall record the experiment on the day it is conducted and preserve the records for five years.

(Transfer of Living Modified Organisms)

Article 6 The notifications specified in Article 18, Paragraphs 1 and 2 of the Regulations shall be

made using the prescribed forms.

(Reporting the completion or discontinuation of experiments)

Article 7 Reports specified in Article 19 of the Regulations shall be made using the prescribed form.

(Preservation of Materials Related to Large-Scale Cultivation Experiments)

Article 8 Materials specified in Article 20 of the Regulations shall be preserved for five years from the date the experiment is approved.

(Education and Training)

Article 9 The education and training specified in Article 21 of the Regulations shall be conducted at least once a year.

(Amendment of these detailed rules)

Article 10 Amendments to these detailed rules shall require the approval of the Safety Committee for Experiments with Genetically Modified Organisms.
